



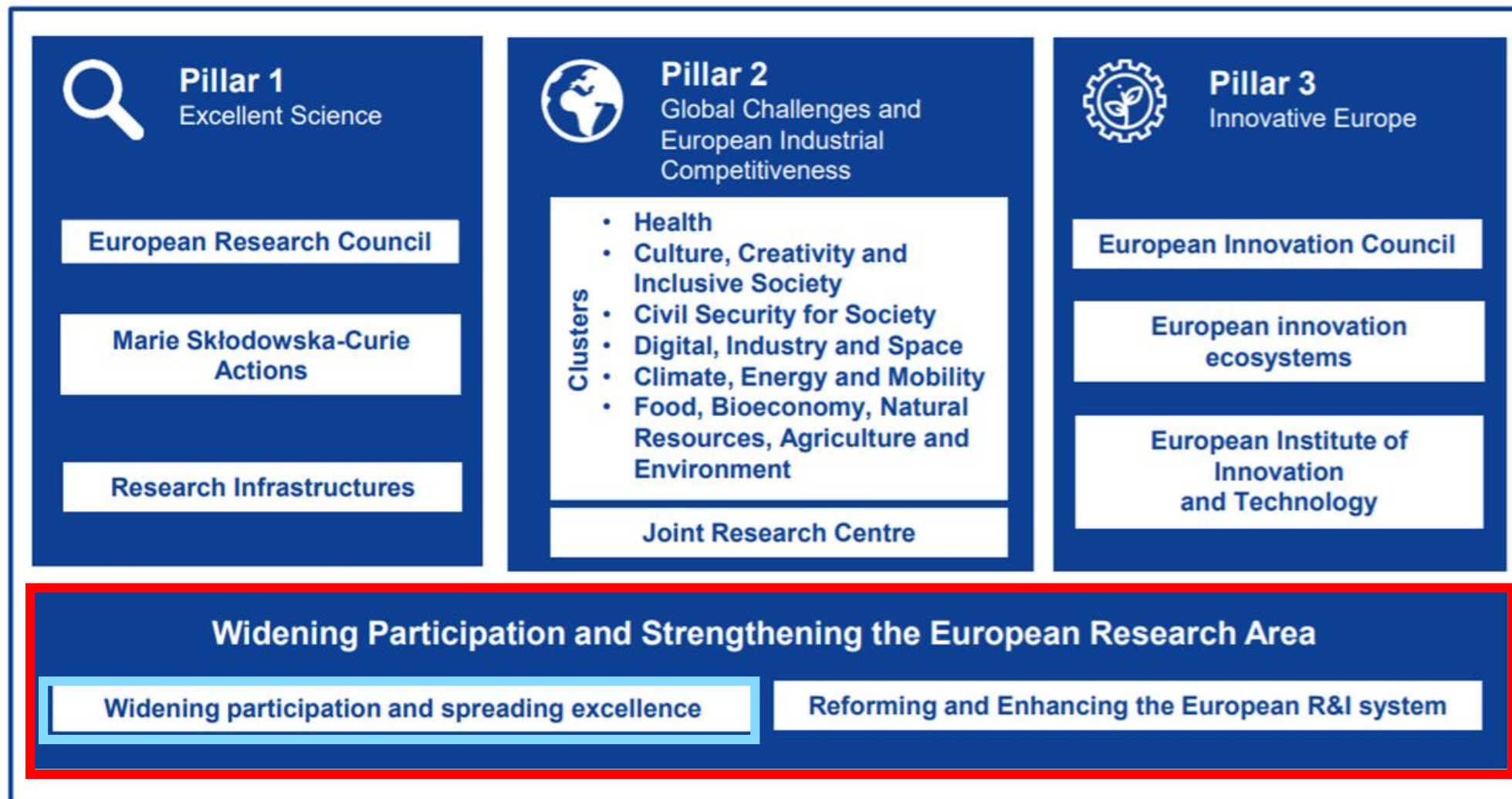

HORIZON STRUCTURE



HORIZONT EVROPA ROZŠIŘOVÁNÍ ÚČASTI A ŠÍŘENÍ EXCELENCE

Snižování přetrvávajících rozdílů ve výkonnosti výzkumu a inovací prostřednictvím sdílení znalostí a odborných poznatků napříč EU nově podpoří balíček opatření nazvaný Advancing Europe Package (AEP), ve kterém čtyři hlavní nástroje z předchozího programu H2020 (TEAMING, TWINNING, ERA Chairs a program COST) doplní nové aktivity a služby. Zažitou terminologií Widening pro nástroje i způsobilé země převzal i program Horizont Evropa.

ZPŮSOBILÉ ZEMĚ

V platnosti zůstává, že pouze subjekty z Widening zemí mohou být koordinátory projektů, ale oproti H2020 se změnila a rozšířila skladba způsobilých zemí: 13 tzv. nových členských států (včetně Česka) doplňuje Portugalsko a Řecko, dosud neurčený počet zemí přidružených k rámcovému programu a nově pak i 9 nejvzdálenějších regionů EU.

UZNATELNOST NÁKLADŮ NA VÝZKUM A INOVACE

Novým prvkem je uznatelnost nákladů na VaI v projektech typu CSA ve výzvách Widening, kterou zavádí článek 2 nařízení zřizujícího program Horizont Evropa. Procentuální poměr nákladů na VaI na celkovém grantu se liší podle druhu nástroje – od 10 % až po 35 %.

PODSTATNÉ NAVÝŠENÍ ROZPOČTU NA WIDENING

Na léta 2021–2027 je na podporu Widening zemí určeno minimálně 3,3 % celkového rozpočtu programu Horizont Evropa, což v současnosti představuje částku ve výši 2,95 miliard €. V rámcovém programu H2020 dosáhl rozpočet na Widening částky 900 milionů €.

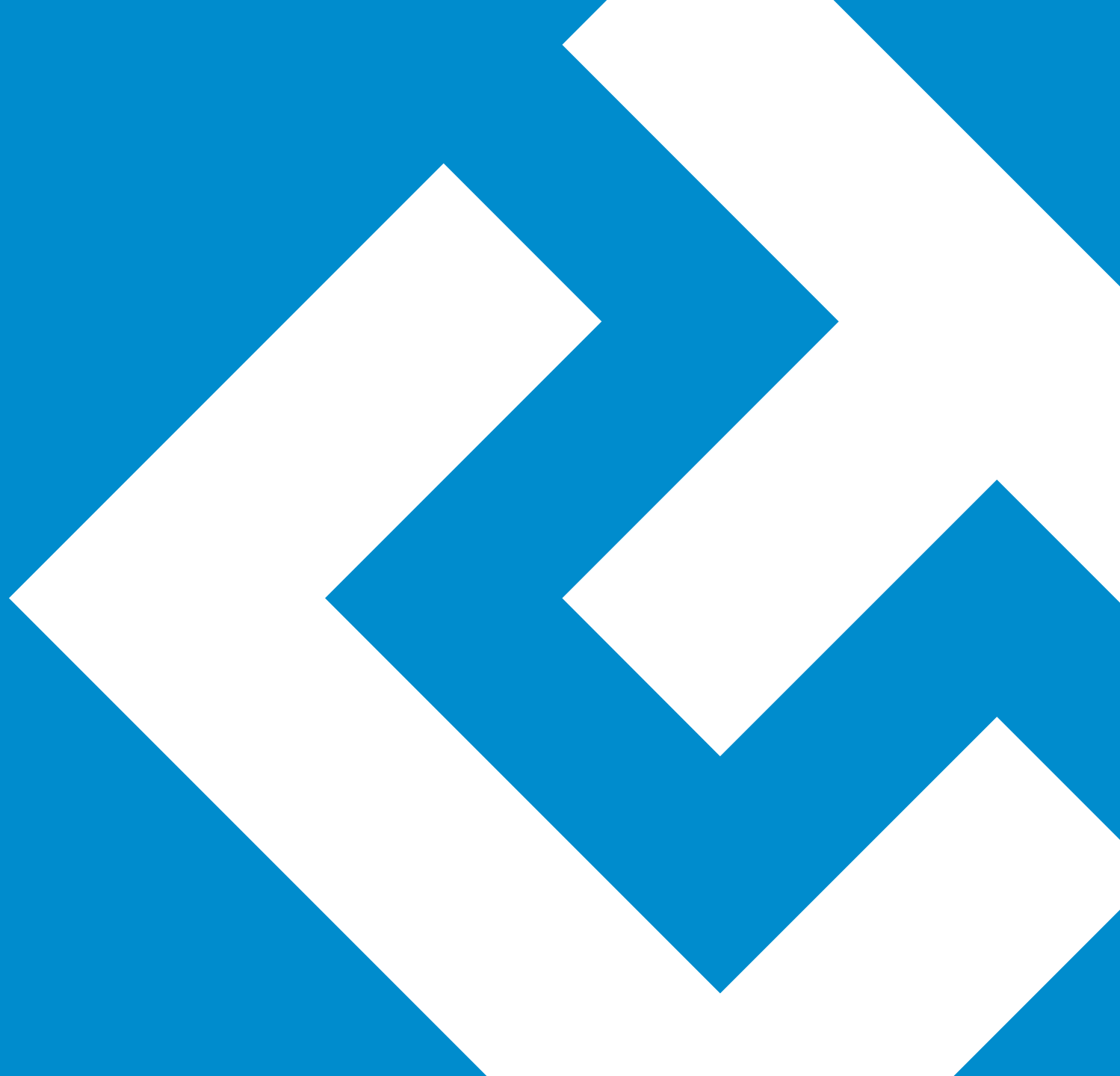

BASIC INFORMATION

- MAIN AIM – institution building: create new centres of excellence or substantially upgrade existing ones
- Two-stage evaluation process
- Complementary funding from other sources at least equal to HE grant (LoC for the 2nd stage)
- Seal of Excellence to applications exceeding all evaluation thresholds but not funded
- A research component up to 10% may include preparatory research project
- CoEs already funded from previous Teaming calls are excluded

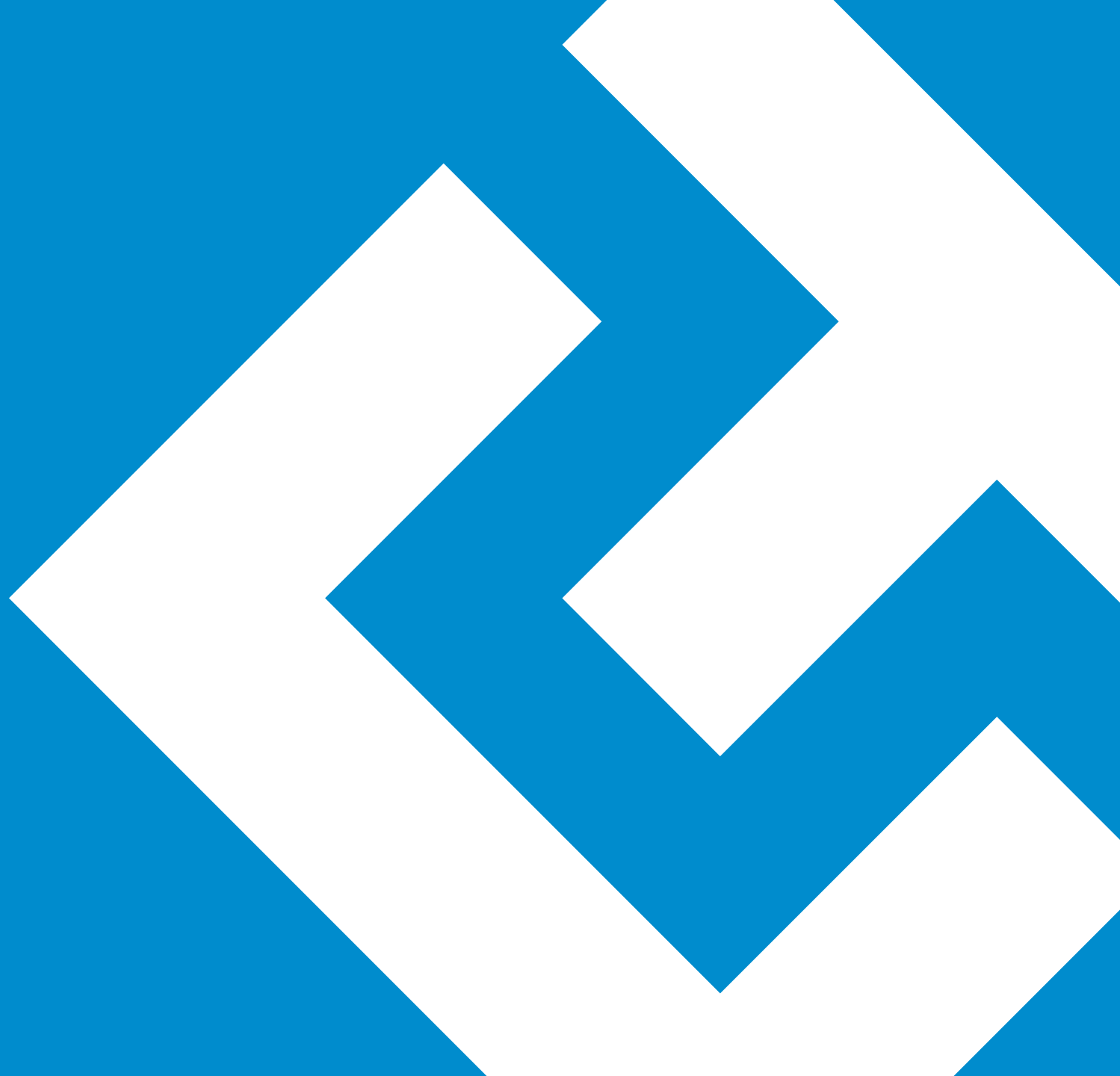

BASIC INFORMATION

- **Chose only one topic:** **NEW**
 - Topic 02-01: TWINNING Bottom-Up
 - Topic 02-02: TWINNING Green Deal
- Both topics have the same objectives, scope and expected impacts and outcomes
- A **Research / innovation component up to 30%** may include a R&I project (dedicated WP) - **at least 50%** of the budget for the research / innovation component must be allocated to the coordinator
- **This action is open for participation of the JRC that can contribute with specific expertise**

- Illustrate quantitatively and qualitatively the expected potential impact and expected results
- Use indicators such as expected future publications in peer reviewed journals, collaboration agreements with businesses, IP, new innovative products or services, no. of international students, number of women scientists and their roles in the research institutions
- Pay specific attention to gender equality objectives
- the presence of a GEP is an eligibility criterion



TWINNING GREEN DEAL - SPECIFICITIES

- European Green Deal (EGD) considers climate change as an opportunity to build a new economic model
- All 27 EU Member States committed to turning the EU into the first climate neutral continent by 2050
- TWINNING GD: **focus on a defined area of research / innovation directly linked to at least one of the actions listed in the EGD strategy:**
 - ❖ Climate research;
 - ❖ Green technologies;
 - ❖ Renewable energy;
 - ❖ Sustainable mobility;
 - ❖ Biodiversity research;
 - ❖ Sustainable use of natural resources (land, water, air).

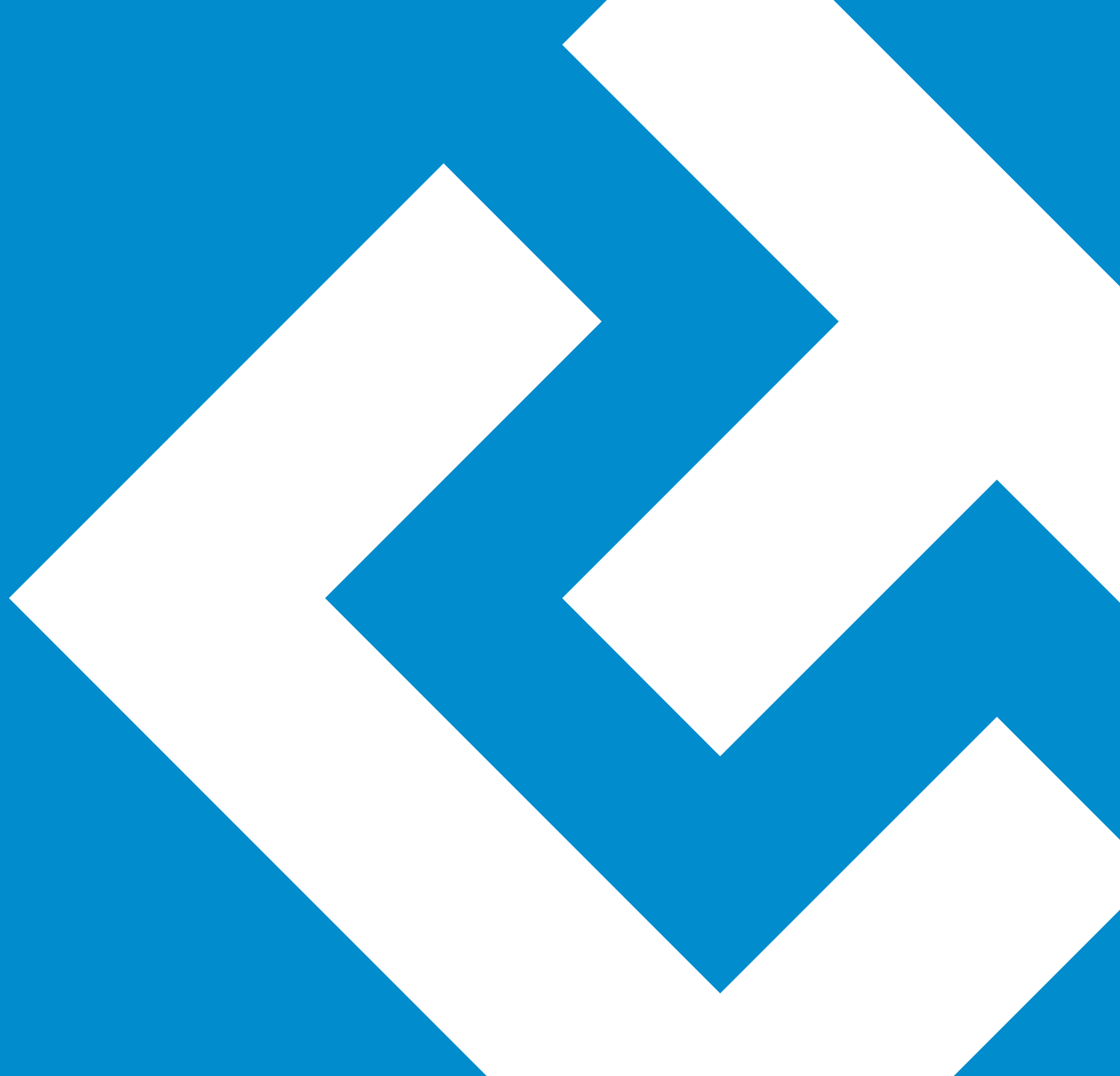

EUROPEAN EXCELLENCE INITIATIVE 2023

BASIC INFORMATION

- Main objectives
 - Raise excellence in science and in value creation through **deeper and geographically inclusive cooperation in alliances of HEIs**, such as – but not limited to – European Universities alliances in Erasmus+, with a particular focus on Widening countries
 - Improve **global competitiveness and visibility of Europe's HEIs**, creating critical mass in key areas such as the green transition and Horizon Europe mission areas
- **Expenditures for R&I activities cannot exceed 20%** of the total project budget
- Applicants have to convincingly demonstrate that the **centre of gravity is in Widening countries, for instance, by a budget allocation of at least 70%** to participants from Widening countries.

- **Increased global competitiveness** of research in higher education institutions
- Contribution to **implementation of the relevant ERA Policy Agenda actions** in higher education sector.



TAKE INTO CONSIDERATION:

- Higher no. of Work Packages due to lump sum funding model is possible
- Projects should:
 - contribute to the implementation of ERA Policy Agenda priorities at the participating HEIs, notably the strengthening of research careers in academia and beyond
 - pursue 8 objectives
 - implement the European Research Area policy objectives and to consolidate institutional changes by means of a coherent package of 11 activities
- Expenditures for research and innovation activities – examples:
 - seed funding for collaborative research projects,
 - activities linked to joint doctoral and postdoctoral research,
 - knowledge valorisation activities.

PATHWAYS TO SYNERGIES 2023

SCOPE:

- Provide support for setting up the interfaces between two different funding systems where major barriers still occur due to the mismatches of regional versus European approach, consortium vs single beneficiary funding and Horizon thematic priorities vs national/regional smart specialisation

OVERALL OUTCOMES

- improved and more systematic synergies between HORIZON & H2020 and ERDF, IPA, RRF and INTERREG through internationalisation, valorisation and technology uptake;
- strengthened competitiveness of R&I actors in Widening countries;
- accelerated knowledge transfer and innovation cycle for beneficiaries from ERDF and HORIZON;
- strengthened innovation capacity and competitiveness of less R&I performing regions.

PATHWAYS TO SYNERGIES 2023

- Incentivise sequential synergies between HORIZON EUROPE and other EU funds notably ERDF in two optional pathways:

a) Upstream pathway

- ✓ focus on human resources development and internationalisation - **move formerly single beneficiaries of regional funding programmes out of isolation via cross-border collaboration and to prepare them for successful participation in HORIZON calls**
- ✓ **Consortium: a core group of at least 3 different public or private research entities from at least 2 different Widening countries that were beneficiaries from ERDF, RRF or similar investments for R&I including infrastructure in the current or previous programming period**

b) Downstream pathway

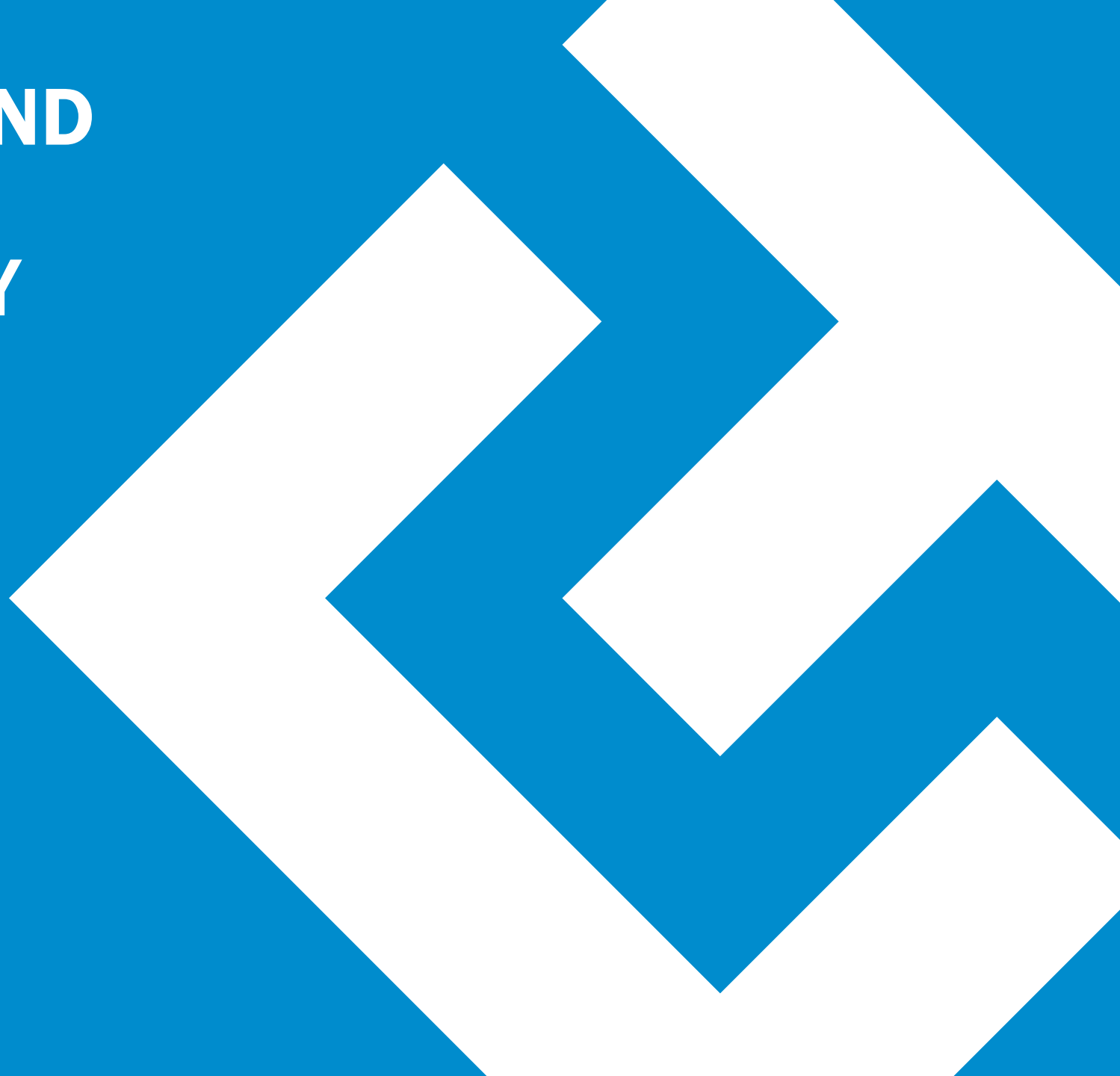
- ✓ **valorisation and upscaling of research results towards marketable solutions** - identify at proposal stage up to three focus regions located in widening countries where the implementation of downstream synergies actually should take place
- ✓ Consortia should be members of a **consortium of 1 or 2 completed or ongoing RIA projects** (in the same domain) funded under HE or H2020 that has already generated validated (e.g. evidenced by approved deliverables, final or periodic reports, peer reviewed publications) research results to be valorised by support from ERDF, IPA, RFF funds or EIC financial instruments

SCOPE

- Support to beneficiaries in their dissemination and exploitation of results through a market-oriented approach

EXPECTED OUTCOMES

- Improved skills and knowledge on D&E, knowledge transfer and IP management;
- Collected and shared best practices for uptake of R&I results and identified blocking elements that prevent beneficiaries from valorising further their R&I results;
- Increased maturity level of key exploitable results;
- Greater recognition of beneficiaries at national & regional policy level, as a result of enhanced visibility of D&E success stories;
- Enhanced synergies between beneficiaries of Widening actions;
- Improved sustainability of ongoing Widening actions;
- Identified downstream synergies with other EU programmes especially ERDF, ESF, RRF.

CONSORTIUM

- **At least 3 entities with a proven track record of success in D&E and related training,** communication and networking; they should ensure that the developed services address the full geographic scope of the Widening countries

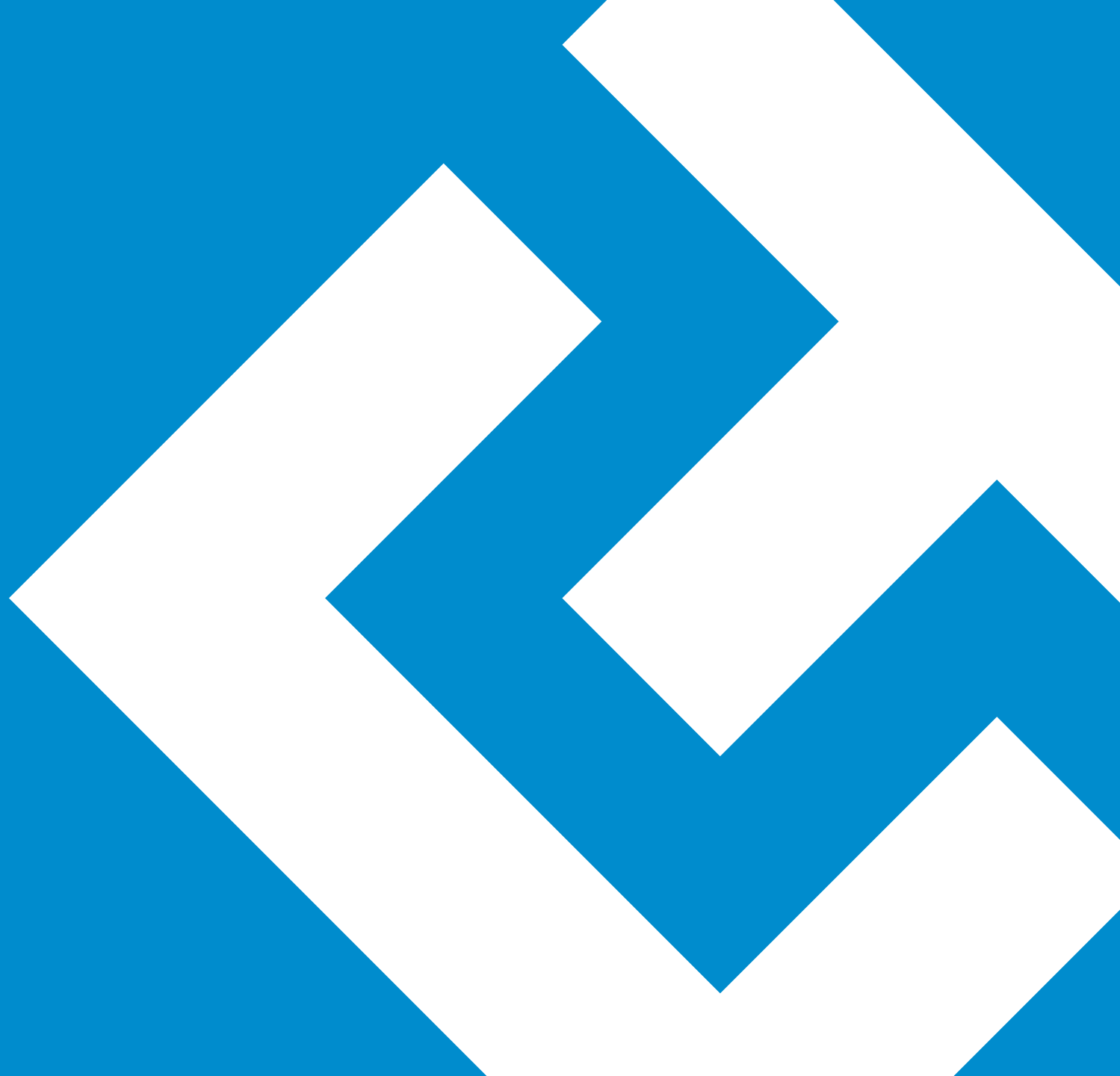
- **A facility including training, upskilling, entrepreneurship, access to capital, best practice sharing, knowledge exchange and community of practice building for beneficiaries of the Widening countries** with a first priority to beneficiaries of ongoing or completed Widening projects funded under H2020 or HORIZON (could be extended to other beneficiaries in WC if budget cannot be exhausted by the widening portfolio)
- **A tailor-made service package** with training, coaching, mapping of results, experts and study visits, peer support, matchmaking events, innovation and IP management, knowledge transfer both in an individualised manner and collective workshop
- AND provide a plan detailing its priorities, the key targets, proposed actions, repartition of budget and regular monitoring on achievements and challenges

NÁSTROJ HOP ON

Nástroj Hop On je jedním ze čtyř nových průřezových opatření balíčku Advancing Europe Package, který v rámci programu Horizont Evropa (HE) doplní čtyři hlavní nástroje z předchozího programu H2020 (TEAMING, TWINNING, ERA Chairs a program COST). Společně cílí na snižování přetrvávajících rozdílů ve výkonnosti výzkumu a inovací prostřednictvím sdílení znalostí a odborných poznatků napříč EU. Nástroj umožňuje přistoupení jednoho partnera ze skupiny tzv. Widening zemí ke konsorciu kolaborativního projektu HE.

ZPŮSOBILÉ PROJEKTY

O nového partnera z Widening zemí se mohou ucházet projekty financované v klustrech Pilíře 2 (Globální výzvy a konkurenceschopnost) a v EIC Pathfinder v Pilíři 3 (Inovativní Evropa) programu HE s již podepsanou grantovou dohodou a bez partnera z jakékoliv Widening země. Jedná se vždy výhradně o kolaborativní projekty typu RIA – Research and Innovation Action. Seznam způsobilých projektů je zveřejněn na Portálu pro finanční příležitosti a veřejné zakázky (FTDP) u výzvy Hop On a je Evropskou komisí aktualizován každý týden. Subjekty z Widening zemí se zájmem o přistoupe-

ni mohou oslovit přímo koordinátora relevantního projektu vyplněním kontaktního formuláře po přihlášení do FTDP (tlačítko Contact u každého projektu).

- **At least two different place based R&I ecosystems in at least two different WCs**
- **Four different categories** in each ecosystem:
 - a) academic institutions
 - b) business entities
 - c) public authorities or authorised agencies
 - d) societal actors

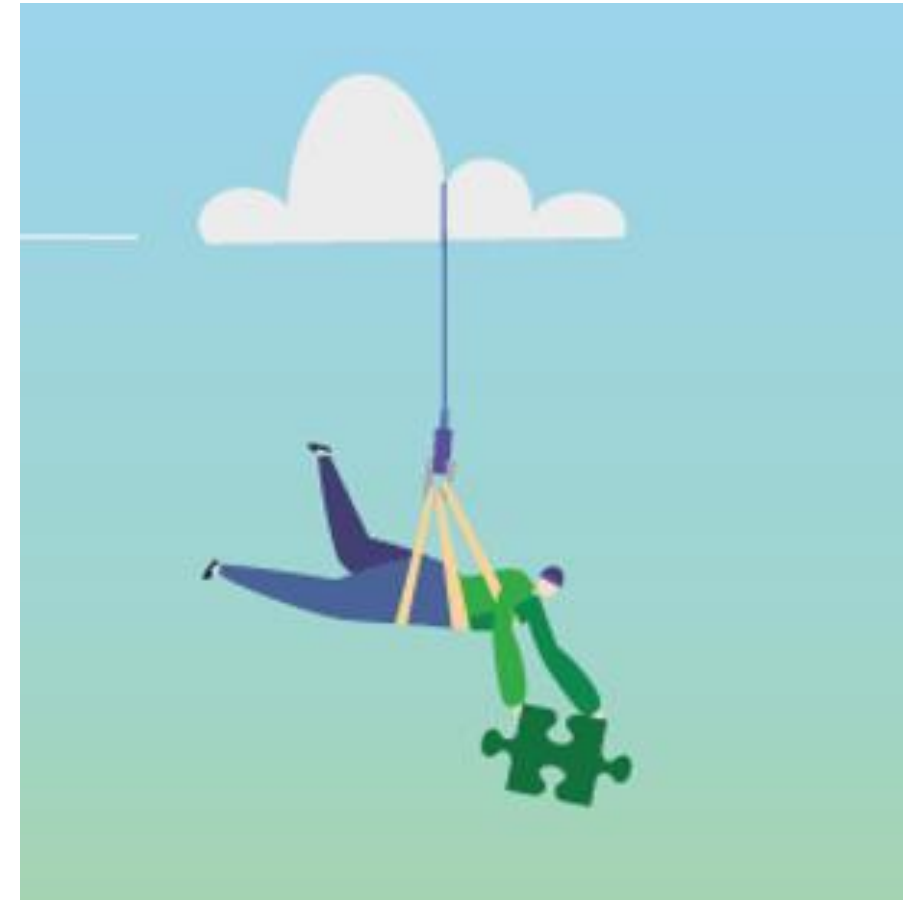

- Consortium: min. 1 + 1 ecosystem
- Project duration: up to 4 years

PAY ATTENTION TO:

Include all 5 core components (+ 1 optional):

- **Cross-border joint R&I strategy** aligned with regional S3 and/or European policy priorities such as the green and digital transition;
- **R&I project** consolidating academia business linkages and providing evidence for strategy building and investment;
- **Action and investment plans** for the implementation of the strategy;
- Conceptual design and **pre-planning for pilots and demonstrators** (if applicable);
- **Accompanying measures** are complementary activities that may promote knowledge and technology transfer, visibility, mutual learning and skills development



TAKE INTO CONSIDERATION:

- Two modes of involvement of a Widening Country R&I ecosystem in the project:
 - The participation, as a beneficiary, by one or more umbrella organisations, whose membership comprises the four different categories of Widening Country R&I actors for the relevant Widening Country;
 - The participation, as beneficiaries, of representative individual legal entities representing each of the four categories of actors for the relevant Widening country.
- Individual participants and ecosystems from other EU Member States, Associated Countries and international co-operation partners may join in duly justified cases e.g., given by a specific expertise needed or the involvement in a relevant value adding chain
- Projects should:
 - Respond to the third priority in the ERA communication on translating R&I results into the economy
 - Contribute to the 10 outcomes
 - Choose between a more regional orientation e.g., by a common denominator in their regional S3 and/or a more global orientation towards European policy priorities such as the green or digital transition

OPTIONAL MENTORING SCHEME

NEW

- Consider providing **financial support to third parties** (FSTP) under the mentoring scheme especially for the support of start-ups and SMEs in the form of grants (maximum amount of such a grant is € 60 000) = cascade funding in H2020
- The scheme budget could be M€ 1
- **Mentoring of an emerging place-based innovation ecosystem established in rural areas, Western Balkans or Eastern Partnership Countries including Ukraine**
- Legal entities from such countries and regions are encouraged to join the project as participants in order to benefit from mentoring, training, knowledge transfer even if their ecosystems are not yet developed to a full quadruple helix structure

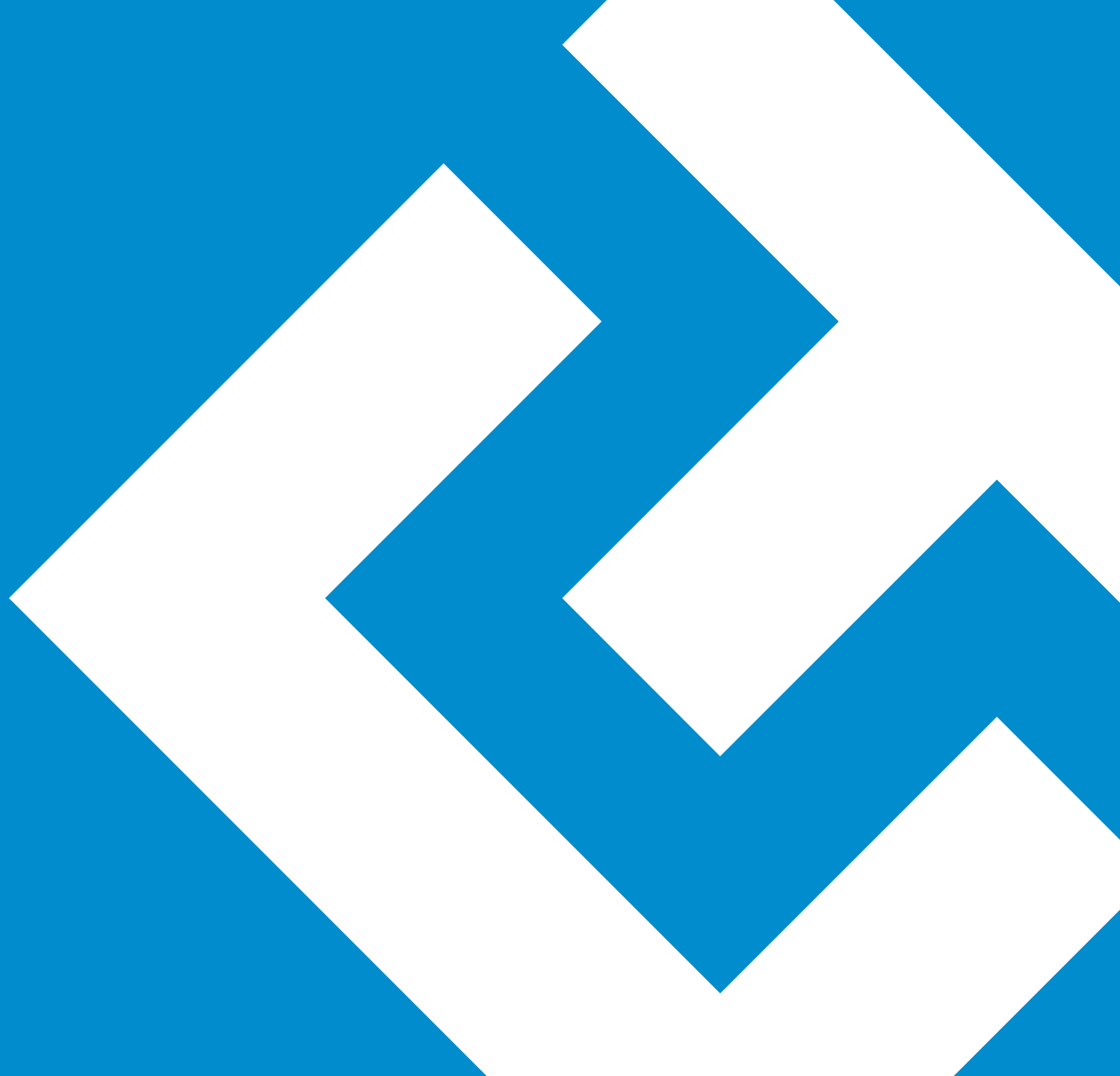

BASIC INFORMATION

- MAIN AIM -- bring **outstanding academics with proven research excellence and management skills** to universities and research institutions (brain gain)
- **Mono beneficiary action with identified future ERA Chair holder**
- **Research costs eligible up to 10%** of the EU contribution
- Proposals must include:
 - a letter signed by the prospective ERA Chair holder expressing his/her commitment
 - a letter from the head of the coordinator institution
 - Curriculum Vitae in Europass form of the future ERA Chair holder

PAY ATTENTION TO:

- The composition, levels of remuneration and timeline of implementation of the ERA Chair holder research team should be indicated
- Selection of personnel to the research team is to be conducted by an international recruitment panel led by the ERA Chair and outlined in proposals
- Team members should be appointed after an open, transparent and merit-based recruitment process with no more than 50% of the team appointees having previous contractual links with the coordinator
- Grant cover expenses related to the ERA Chair holder and his team members (e.g., salaries, recruitment costs, administrative costs, travel and subsistence costs) and cost of measures aimed at introducing structural changes in the institution (e.g., costs for trainings, meetings, publications or managing IPR)



TAKE INTO CONSIDERATION:

- ERA Chair holders can be citizens of any country in the world
- Demonstrate that ERA Chair research team will have conditions to thrive after the end of the project and include the **appointment of this new research group leader on a permanent basis during the initial 3 years**
- Projects are expected to contribute to some of the 7 outcomes on system level and 5 on organisational level
- ERA Chair holder should have a position allowing him to make appropriate resource allocation decisions, supervise team members and freely apply for research funding
- **He/she might move on a temporary or permanent basis** to the coordinator's premises. Secondments or any other legal arrangements (e.g., leave without pay, sabbatical licences) are possible including part-time work and multiple stays. **All contractual arrangements and the timeline of ERA Chairs stays should be indicated** as well as the salary, travel and daily allowances and/or other perks to be offered.

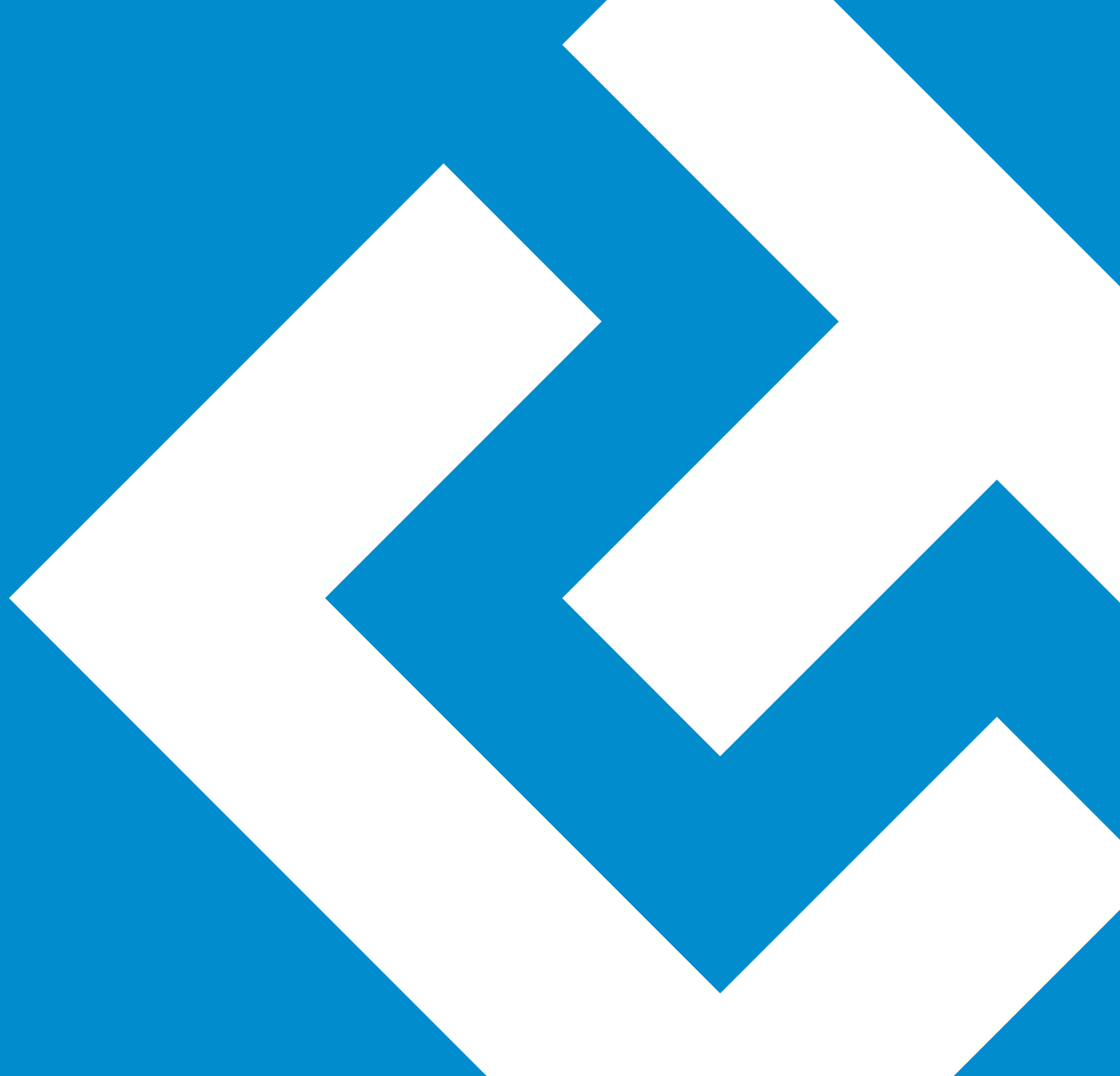

- MAIN AIM – to **boost interoperability of careers and employability of research and innovation talents across sectors**, with a centre of gravity in Widening countries
- Seconded staff must be actively engaged **at least 6 months (FTE) at the sending institution** before the (first) period of secondment
- Need to provide an estimate of the number of the seconded ERA talents

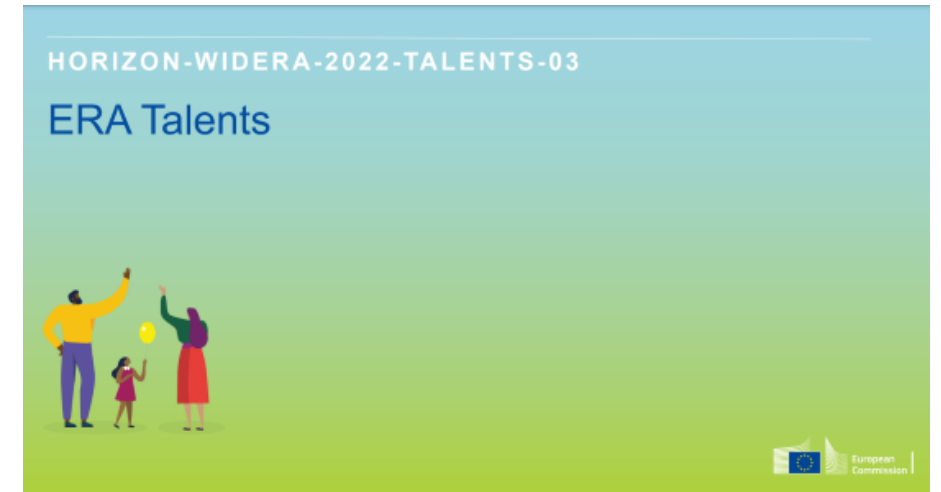

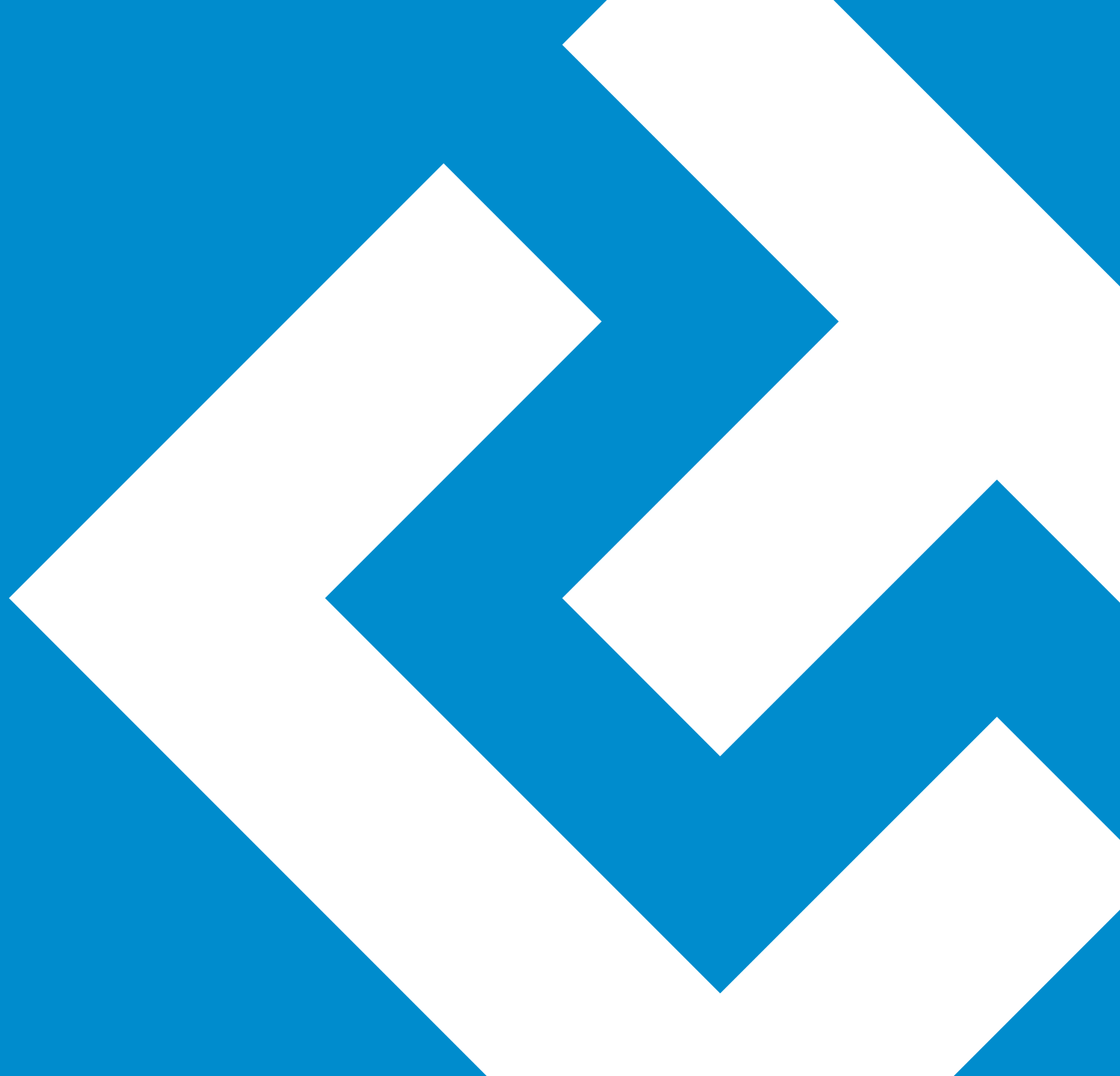
