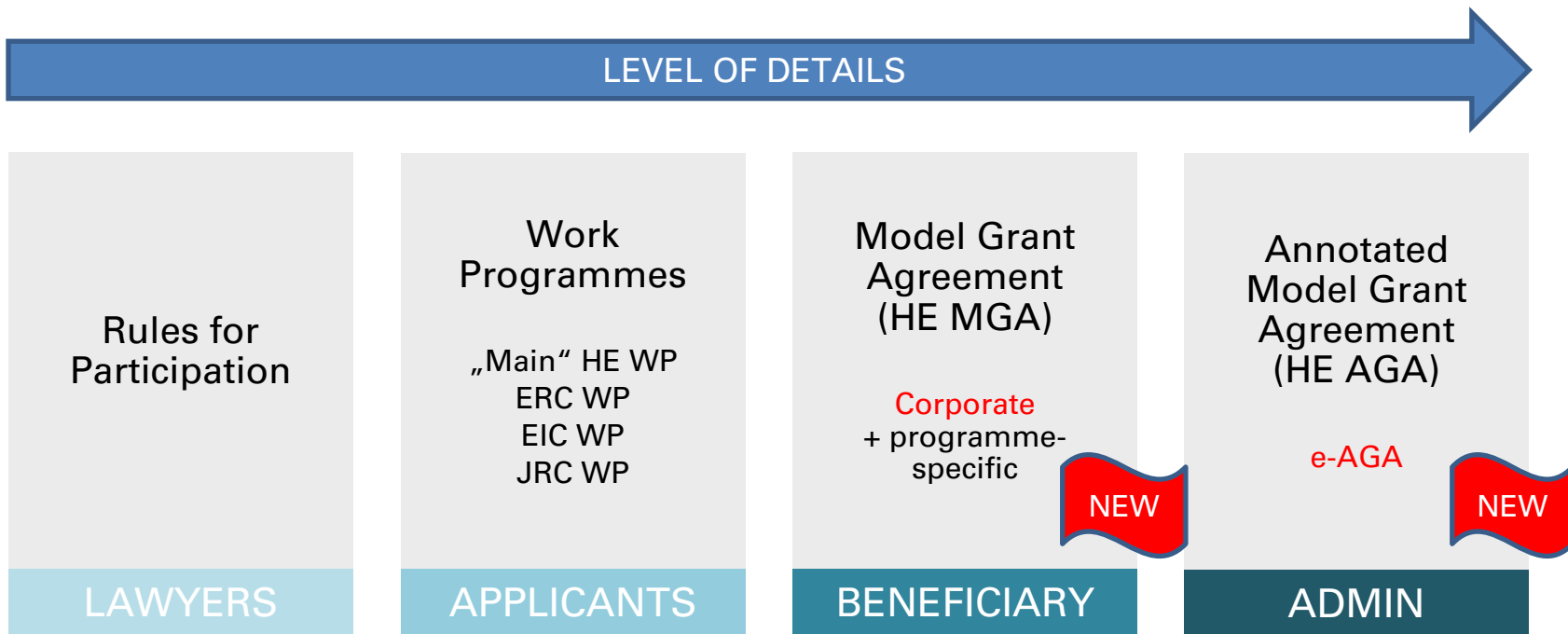

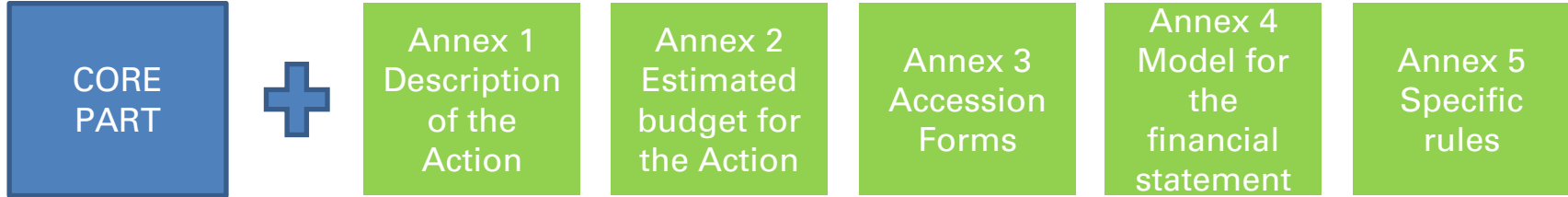

# PROTECTION of RESULTS

„[...] if protection is **possible and justified**, taking into account all relevant considerations, including the **prospects for commercial exploitation**, the legitimate interests of the other beneficiaries and any other legitimate interests.“



# EXPLOITATION of RESULTS

„If despite best efforts no exploitation takes place within one year after the end of the action, the beneficiaries must (unless otherwise agreed in writing with the granting authority) use the **Horizon Results Platform** to find interested parties to exploit the results. “


