**EMROD (Interreg V-A Euregio Meuse-Rhine)** coordinating police, justice, preventive services and administrative authorities to analyse and scientifically combat crime (drugs, burglary, etc.) across the region.

**PANDEMRIC (Interreg V-A Euregio Meuse-Rhine)** in response to the COVID-19 crisis: analysis of the impact of national measures and improving information exchange and coordination between health services, particularly intensive care units > creation of a central purchasing body for protective equipment.

**EMFloodResilience (Interreg V-A Euregio Meuse-Rhine)** strengthening cooperation between Belgian, Dutch and German stakeholders after the disastrous flood event in July 2021 > hydraulic studies providing relevant data on rivers behaviour, identify critical infrastructure, areas at risk and deliver recommendations for post-disaster building works

**FlashFloodBreaker (Interreg North-West Europe)** > integrated modelling, artificial intelligence and drones to improve flashfloods preparedness and coordination.

	Multi-actors synergies between local authorities, emergency services, institutional partners and civil society in order to jointly develop approaches tailored to the current challenges of climate change and emerging risks. Consequently, it is able to contribute to EU projects at both institutional and operational levels.
	<ul> <li>Innovative solutions for risks prevention and early warning tools based on lessons learned from past disasters and EU projects outcomes</li> </ul>
	Co-developed hydraulic risk maps and dynamic crisis management scenarios incorporating real-time data (advanced GIS tools dedicated to decision-making support for local authorities).
	Inclusive and participatory solutions for raising citizens risk-awareness and strengthening societal resilience to climate change in collaboration with its emergency services and the Governor's departments. For example, during the floods of July 2021, the Province mobilised more than 300 officers and allocated a budget of nearly €2.4 million to coordinate emergency operations, support the affected municipalities and manage operations on infrastructure and waterways.
	<b>Examples of innovative tools to share</b> : "The sandbag science", the "International Handbook on Emergency Management for flood defences", the "Cit'InCrise" and "RiskFactory" games

Integration and use of advanced technologies	Mainly through the "FlashFloodBreaker" project, early warning tools and rivers stress tests, practical expertise in integrating advanced technologies into risk management (Automated warning systems, drones, artificial intelligence forecasting models and decision-making tools for emergency services). This technical and operational expertise is an asset in strengthening the consortium's digital and predictive capabilities.
Training activities and capacity building	The Provincial Public Training institute (IPFASSU) regularly organises field training and crisis simulation exercises in collaboration with emergency services, municipalities and the Governor's office; For example, the "CrisEXInter" exercises based on the Swedish Emergo Train System of crisis simulation. These activities are part of a strategy to improve the skills of first responders and local authorities. It includes modules on crisis communication, multi-level coordination and the use of new technological tools. It is also able and willing to implement public raising awareness campaigns (e.g. on flood risks or risk culture). Thanks to its local roots and educational resources, it contributes to strengthening the capacities (the 'social sciences and humanities' aspect) and long-term preparedness of the various actors in the field.
