



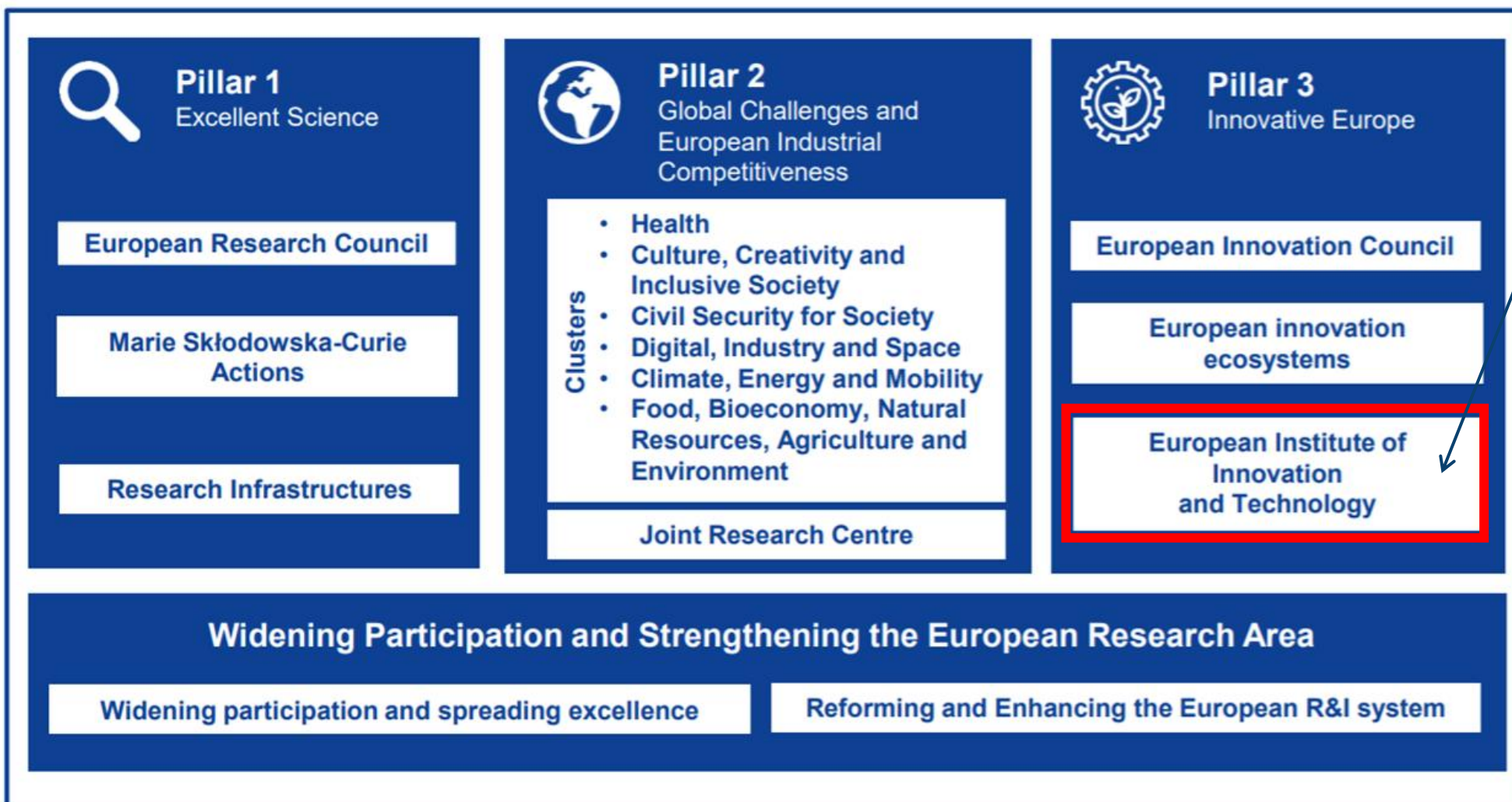

- Member States Representative Group established in Autumn 2021

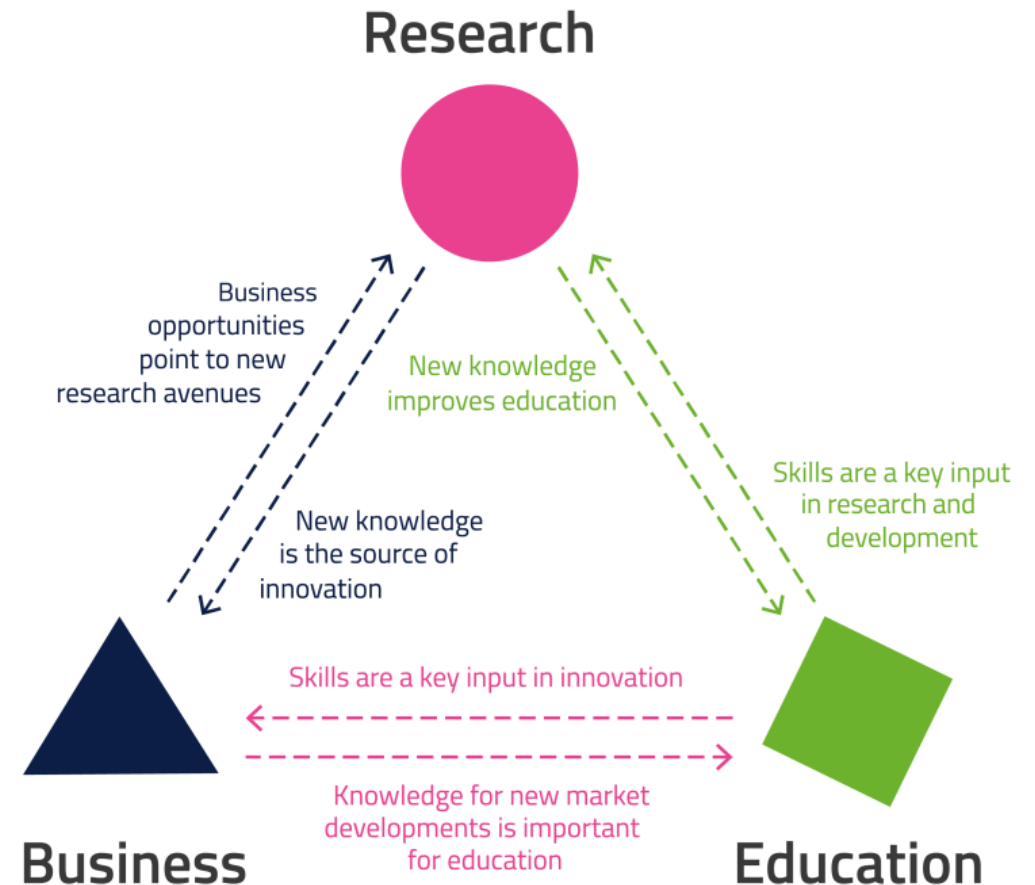

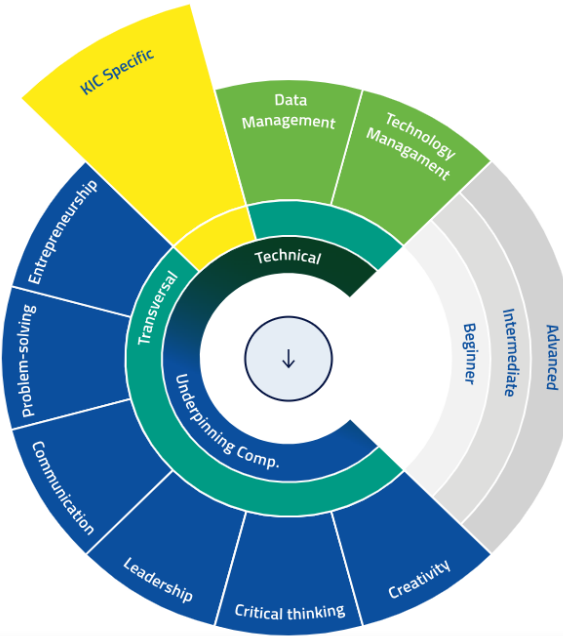


2028 - 2034
